Our system is among the first called to help in times of difficulty. Throughout these challenges, we persevere. We have seen the certification of the first 9 CCBHCs in our state and are hopeful that more will seek and receive their certifications in the coming months with the likelihood that our CMHC system will be on pace to have a system full of CCBHCs by 2024. With a handful of states now working toward Kansas-like CCBHC legislation, we are on the cusp of national behavioral health leadership once again. Our collaboration with state and local governments is at the highest level it has been since I joined the Association nearly a decade ago and our work on CCBHCs would not be possible without that collaboration.

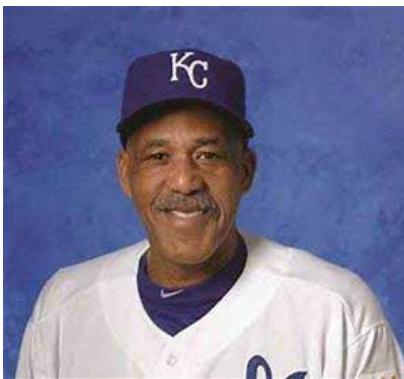
Featured Speakers

Prior to becoming President and CEO of the National Council for Behavioral Health, he served as the Senior VP of Public Policy and Practice Improvement. He also serves as adjunct faculty at the George Washington University Graduate School of Political Management.

Willie Aikens played eight seasons in Major League Baseball including with the Kansas City Royals, California Angels and Toronto Blue Jays. He won an American League Pennant as a member of the Royals and hit four home runs in the World Series.

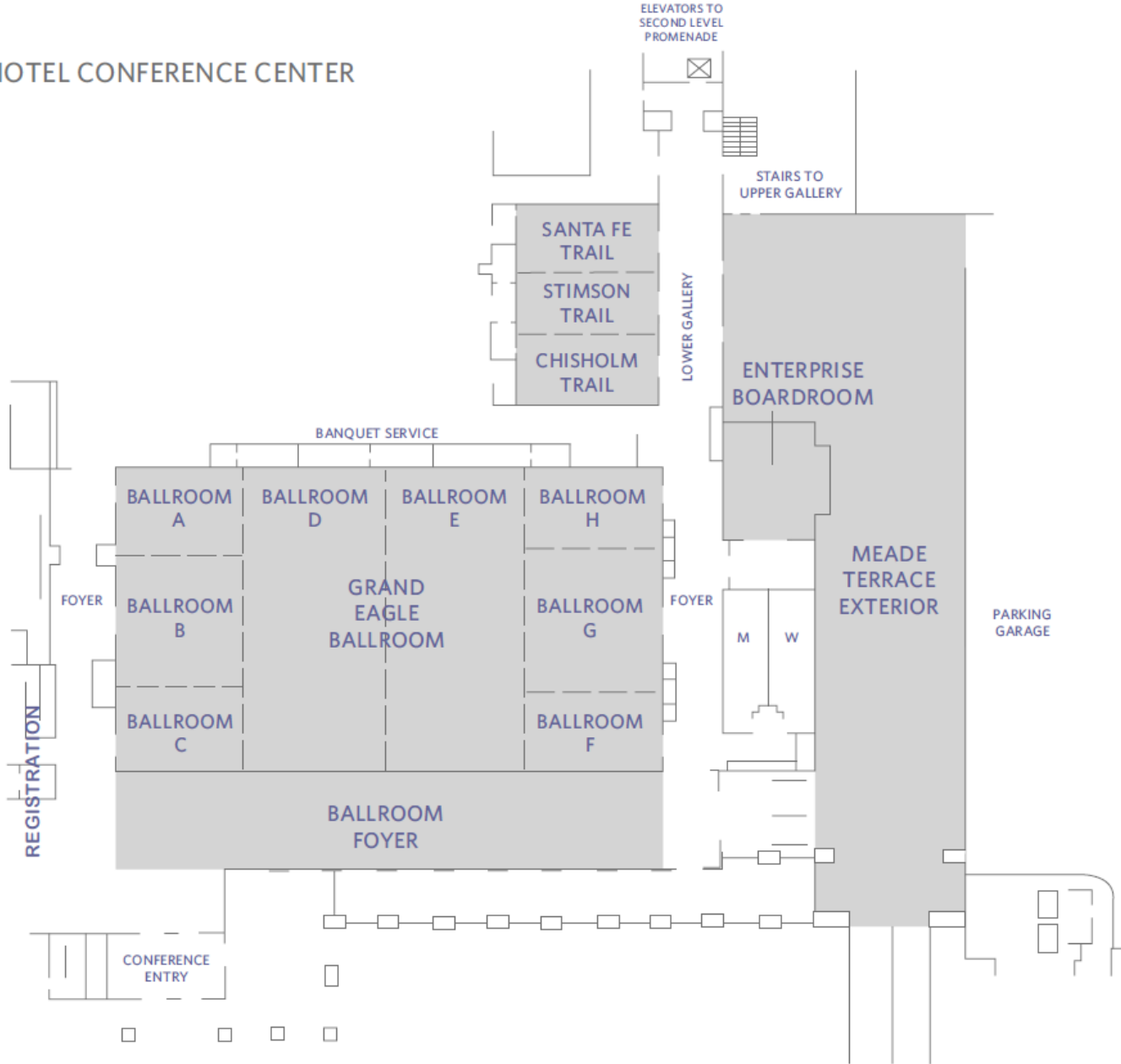

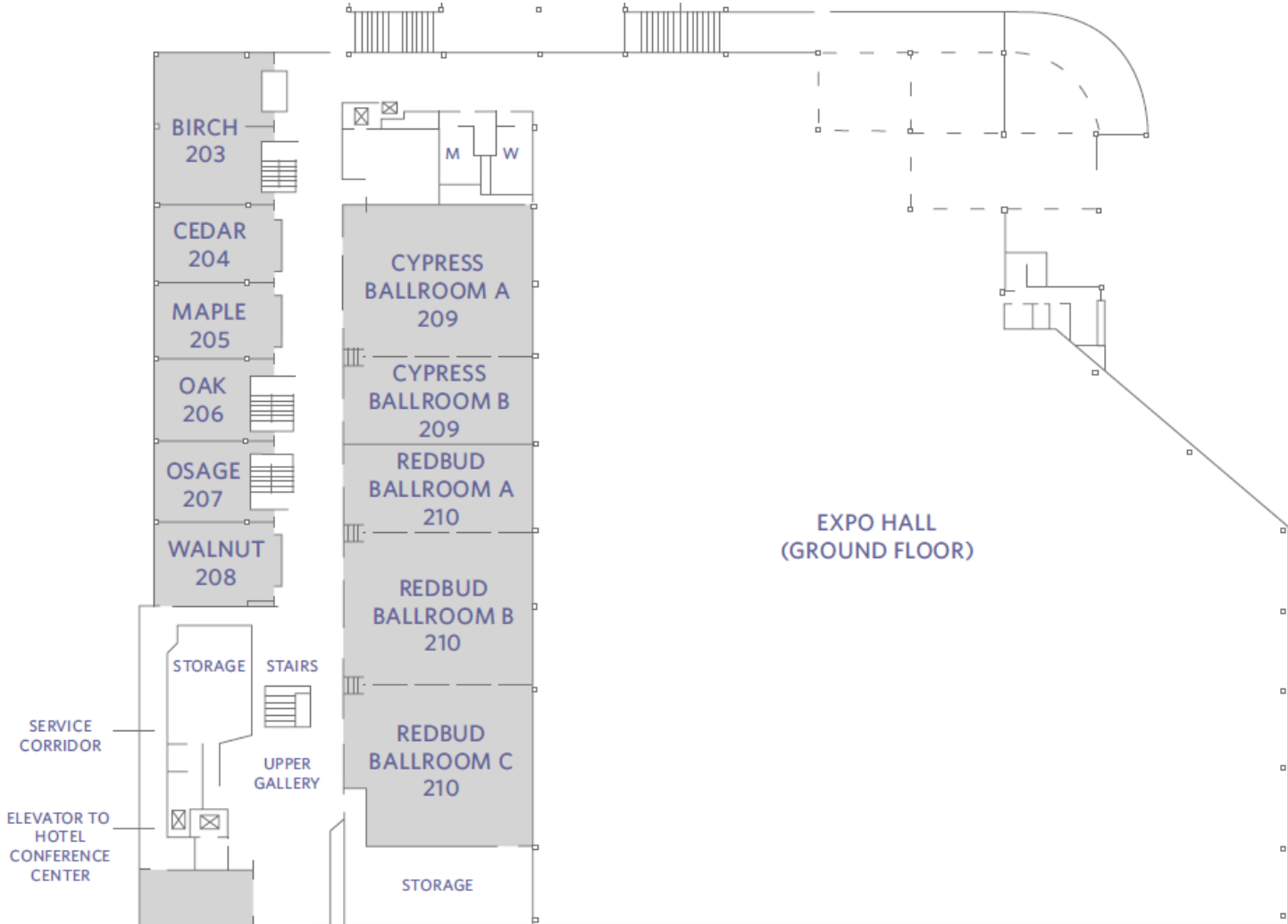

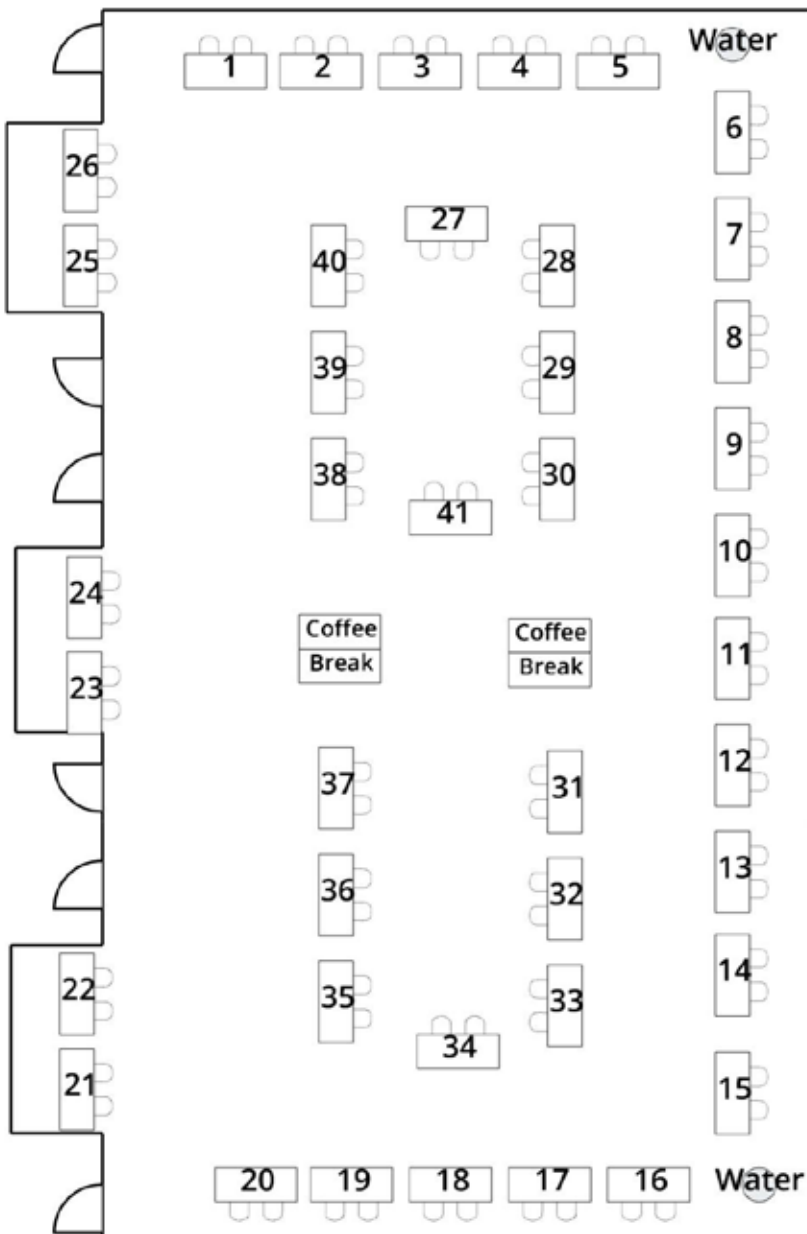
